OVERALL PROGRAMMING SPECIFICATIONS

A. Format

1. There are three potential elements to any question: instructions before the question, the question itself (including answer categories), and instructions following the question. The first two are identified by the question number, and the last one is specified by "Programmer Specifications."
2. In addition to questions, there are double-lined boxes (labeled BOX PM1, BOX PM2, etc.) that contain instructions which do not include a question but direct the flow of the application.

B. Flow

1. If no flow instructions are specified, default to the next question box.
2. Flow may be specified in one of two ways. Simple flow -- which depends only on the question currently being asked -- may be expressed in parentheses after the question categories. Anything more than simple flow (including flow instructions that involve missing data such as DK or RF, or that involve answers to previous questions) is expressed in the double-lined boxes, as described above.

C. Displays

1. Gender. We know the gender of the SP, either from sampling or from question RH6 in Residence History. If the gender is male, display "he" wherever a "{she/he}" is encountered; if female, display "she"; otherwise, display "he or she".
2. Read Facilities in Header above. There are no place headers in Residence History. All other SP-level sections feature a header that includes the eligible LTC places in this facility (i.e., places with NNHES status = eligible) where the SP resided during the reference period. The only exceptions are screens that include the Place Roster; these screens have no places in the header.

For screens that don't include the Place Roster in HS, PM, BQ, IN, IA, USE, EX, and CRR, the eligible unit where the SP lived during the reference period is displayed right-justified on the second line of the screen. If the SP lived in two or three eligible units during the reference period, they are right-justified on the third and fourth lines. If the SP lived in more than three eligible units, the fourth line reads: "MORE UNITS - USE F2" and is right-justified.

3. In Round 1, for Current Residents, set the {REFERENCE START DATE} to "January". In Round 2 for F2s and in Round 3 for F3s, set the {REFERENCE START DATE} to {MONTH OF SAD}. If the SP is a resident in a NEW FACILITY, set the {REFERENCE START DATE} to {MONTH OF TAD}.

If the SP is alive and living in the eligible facility/eligible unit on the date of the interview, set the {REFERENCE END DATE} to the last calendar month, preceding the date of interview, in which the SP was in the eligible facility/eligible unit for at least one day.

If Round 1 or Round 2 and the SP is deceased, set {REFERENCE END DATE} to the {MONTH OF DATE OF DEATH}.

If Round 1 or Round 2 and {MONTH OF DATE OF DISCHARGE} = {MONTH OF DATE OF INTERVIEW}, set {REFERENCE END DATE} to the last calendar month preceding the date of interview in which the SP was in the eligible facility/eligible unit for at least one day.

Else if Round 1 or Round 2 and {MONTH OF DATE OF DISCHARGE} precedes {MONTH OF DATE OF INTERVIEW}, set {REFERENCE END DATE} to the {MONTH OF DATE OF DISCHARGE}.

If Round 3 and SP is alive and living in eligible facility/eligible unit, set {REFERENCE END DATE} to "December."

If Round 3 and SP is discharged, set {REFERENCE END DATE} to {MONTH OF MOST RECENT DISCHARGE} or "December", whichever is earliest. If Round 3 and SP is deceased, set {REFERENCE END DATE} to {MONTH OF DATE OF DEATH} or "December", whichever is earliest.

In R1 or R2, if the month of {DATE OF DEATH} or {DATE OF DISCHARGE} is unknown, set {REFERENCE END DATE} to {MONTH OF DATE OF INTERVIEW}.

In R3, if the month of {DATE OF DEATH} or {DATE OF DISCHARGE} is unknown, set {REFERENCE END DATE} to "December".

In subsequent rounds, begin the PM reference period with any {REFERENCE DATES} flagged for data retrieval. Then, if the SP was alive and living in the eligible facility/eligible unit on the date of interview in the previous round, set the {REFERENCE DATE} to start at the month immediately after the {REFERENCE END DATE} of the previous round.

4. DK/RF. Unless otherwise specified, do not display DK and RF.

D. Missing Data

The PM missing data module is created when an <Escape> is made from the PM module and there is one or more REFERENCE DATEs in PM1A for which prescribed medicines data has not been collected.

When the status of PM is set to MD on the SP navigate screen, an entry on that cell initiates the PM MD module.

Display PM1A as a choice roster, displaying on the roster all of the months in the REFERENCE PERIOD for which prescribed medicines are to be collected for this SP during this round.

Display the months in order from earliest to latest.

Always display all {REFERENCE DATE}s sequentially, beginning with the {REFERENCE START DATE} and ending with the {REFERENCE END DATE}, including all months between those dates in which the SP resided in the sampled facility/eligible unit at least one day. If an SP was not residing in the sampled facility/eligible unit on any day during a given month, do not display that month. For example, for a CR who was in the facility from January 1996 through the date of the Round 1 interview, April 4, 1996, PM1A will display "JANUARY 1996", "FEBRUARY 1996", "MARCH 1996". If the SP had been discharged from the facility in January and readmitted in March and was not in the facility for a single day in February, then the reference dates would be "JANUARY 1996" and "MARCH 1996". This design of the application is meant to mirror the month by month format of most prescribed medicine charts.

When a month has been selected, do not display that month the next time this choice roster is called up.

If there is only one REFERENCE DATE when first coming to PM1A, display "Is the prescribed medicine chart for {SP} for {REFERENCE DATE} available?" The fill for "REFERENCE DATE" in the question text should match the month on the roster on which the cursor resides.

Else display "What is the {first/next} month the prescribed medicine chart is available for {SP}?"

Display "first" if this is the first time PM1A has been asked for this SP in this round; else display "next".

The first time through PM8 (that is, the number of times a medicine was administered during the (REFERENCE START DATE)), the question begins to build a matrix used throughout the REFERENCE PERIOD. The matrix has a column of DRUG ATTRIBUTES (which includes NAME OF MEDICINE, NUMBER, STRENGTH on the first line and FORM and DOSAGE on the second line), NUMBER (of times administered during the month) and DISCONTINUED (which is always set by default to "NO").

When a medicine is reported, a frequency of administration is collected, and that medicine is displayed in all future iterations of the matrix (unless DISCONTINUED is set to "YES" or the medicine is "deleted" from the matrix (SHIFT/5)).

The matrix lists all medicines reported in the prior month and not discontinued or deleted in the left most column (in the order in which they are collected).

The entry field for NUMBER is in the next column, and the DISCONTINUED column is to the far right.

Else, if prior month is not available, list all medicines reported and not discontinued or deleted in the nearest prior month, backing up as far as January 1996 to find a month having at least one such medicine.

Else, begin "new" month at PM2.

Else, list all medicines reported and not marked as discontinued or deleted in the nearest subsequent month.

The question is initiated with the cursor residing on the first cell in the NUMBER OF TIMES column. The cursor can be moved through columns and rows by using the arrow key. A valid entry (see ranges) in the NUMBER moves the cursor to the DISCONTINUED column. This column can be arrowed through, or if a drug has been discontinued, the "NO" can be overwritten by typing "1" for "YES". (A "YES" may also be overwritten by typing "0" for "NO".)

Escape from the matrix goes to PM9; allow <Escape> from the matrix even if there is a "NUMBER" field in which there has been no entry.

If medicine was added (<Escape> was entered in PM2 without selecting a medicine) display on first line for each medicine, "NAME OF MEDICINE" from PM2A, "NUMBER" from PM5 and "STRENGTH" from PM4 and display on second line, indented, "FORM" FROM PM3 and "DOSAGE" from PM7 (using the text that is displayed in parentheses in answer categories for PM7);

Else, if form and strength were added to a selected medicine ("ADD FORM AND STRENGTH" was selected in PM2B), display on first line for each medicine, "NAME OF MEDICINE" from PM2, "NUMBER" from PM5 and "STRENGTH" from PM4 and display on second line, indented, "FORM" from PM3 and "DOSAGE" from PM7 (using text, as specified earlier);

Else, if no strength specified (-5 selected at PM4), only display on first line for each medicine, "NAME OF MEDICINE" and "NUMBER" and on second line, indented, "FORM" and "DOSAGE";

Else, if combination medicine (96 selected at PM4), display "NAME OF MEDICINE" from PM2B, "NUMBER" from PM5, and both "STRENGTH"s from PM4 on first line and on second line, "FORM" from PM3 and "DOSAGE" from PM7.

"Prescribed medicines administered" refers to all medicines listed on the resident's Prescribed Medicines chart, regardless of whether the SP took the medicine.

For example, it's possible that a resident whose chart indicates a prescribed medicine with a dosage of PRN (standing order, administer as necessary) will never take that medicine during the reference month. Another example is a prescribed medicine that is refused by the resident. These medicines should be recorded as "administered".

PM5

"Dosage" has two attributes -- the number of units (pills, injections, patches, and so on) of a particular strength of medicine to be received at one time and how often this number of units is to be received. For example, 2 250 mg tablets of ibuprofen, every four hours, where "2" represents the number of units, "250 mg" the strength, and "every four hours" the frequency at which it is to be administered.
